Plans are required for all building types and shall be prepared by or under the direct supervision of an architect or engineer licensed pursuant to Act No. 299 of the Public Acts of 1980, as amended and shall bear that architect's or engineer's signature and seal except:

1. One and Two family dwelling containing not more than 3,500 square feet.
2. Alterations and repair work determined by the Electrical Official to be of a minor nature.
3. Assembly, Business, Mercantile and Storage buildings with a required Electrical fixture count less than 12.
4. Work completed by a governmental subdivision of State agency costing less than \$15,000.00

V. CONTRACTOR SIGNATURE

Section 23a of the State Construction Code Act of 1972, 1972 PA 230, MCL 125.1523AA, prohibits a person from conspiring to circumvent the licensing requirements of this State relating to persons who are to perform work on a residential building or a residential structure. ***If installing a service panel, one (1) inspection is required for each service panel and at least one (1) additional inspection (i.e. rough, final, underground, etc) for all other items. If you are finishing the area the electrical work is being done, both a rough and final inspection will be required in addition to any service panel or underground inspections.**

**** All electrical plan reviews are billed at \$80 per hour and are based on the inspectors hours billed for the review. All fees must be paid prior to permit being issued.**

FEE CLARIFICATION:

MOBILE HOME PARK SITE: When installing a site service in a park, the permit application must include the application fee, service, plus the number of park sites. When setting a HUD mobile home or a pre-manufactured home on private property, a permit must include the application fee, service and feeder.

INSTRUCTIONS FOR COMPLETING APPLICATION:

GENERAL: Electrical work shall not be started until a permit has been obtained. All installations shall be in conformance with the Electrical Code. No work shall be concealed until it has been inspected.

When ready for an inspection, call the Township providing as much advance notice as possible. The Township will need the job location and permit number. When ready for an inspection, call the Township with as much notice as possible.

EXPIRATION OF PERMIT: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six (6) months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six (6) months after the time of commencing the work. A PERMIT WILL BE CANCELLED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX (6) MONTHS OF THE DATE OF ISSUANCE, OR THE DATE OF THE LAST INSPECTION. CANCELLED PERMITS CANNOT BE REFUNDED OR REINSTATED.
